

## Health & Safety Policy Statement Of Intent

- Health and Safety Policies, Standards and Management Systems (including procedures and work instructions) will be defined, documented, implemented and maintained
- Creating for staff, as far as is practicable, a working environment where potential work-related stressors are avoided, minimised or mitigated through good management practices, effective human resources policies and staff development
- Ensuring, as far as reasonably practicable, that risks associated with travel by staff for Walcote Health Ltd are appropriately managed
- Making sure that all staff are aware of their health and safety responsibilities and know what is expected of them, and what they must do to discharge the responsibilities assigned to them
- Providing access for staff to appropriate training and development to enable them to discharge competently the responsibilities assigned to them
- Having an effective system for communicating and consulting on health and safety matters and securing the co- operation of staff, Patients, other healthcare providers working from the premises of Walcote Health Ltd, and commissioners in implementing the Health and Safety Policy
- To have in place arrangements to plan, implement, monitor and review measures to address risks arising from the activities of Walcote Health Ltd
- To strive for continuous improvements in the health and safety performance of Walcote Health Ltd
- Appointing a competent person to support Walcote Health Ltd to meet our statutory duties which include all reporting requirements
